# MINUTES OF THE ANNUAL MEETING OF ISLE ABBOTTS PARISH COUNCIL HELD ON WEDNESDAY $9^{\text{TH}}$ JULY AT 7.30pm IN THE VILLAGE HALL

25/41 ATTENDANCE AND APOLOGIES

Present: Cllrs Lockley, Vaun Davis and Hillman; the Clerk

Apologies: Cllr Westworth and Richards

25/42 DECLARATIONS OF INTEREST: None.

25/43 MINUTES: RESOLVED that the minutes of the meeting on Wednesday 14<sup>th</sup> May were a correct record and were duly signed by the Chair.

### 25/44 PLANNING APPLICATIONS:

- a) 25/01381/S73: S73 application to vary conditions 2 (approved plans), 9 (Archaeology), 10 (NNAMS) and 11 (Construction Environmental Management Plan) of approval 21/00409/FUL for Change of use of agricultural land to residential for the erection of 2 No. single storey dwellings with garaging & shared vehicular access and a track and gate to serve the adjoining agricultural land Land At Isle Abbotts Taunton Somerset.
  - After lengthy discussion, the council RESOLVED to submit an OBJECTION to the application. The council felt the proposed changes would have a significant impact on visual amenity and that the scale of the changes represented too great a deviation from the previously approved application to be assessed under a Section 73 application. A new full application should be submitted. The council also expressed disappointment at the proposed use of phosphate credits rather than the originally proposed local mitigation scheme. Concerns were also raised regarding ecological management during construction.
- b) 25/01577/TCA: Notification of intent to perform tree surgery works to T1 Lime, T2 Sycamore and T3 Conifer included within Conservation Area Church Of St Mary The Virgin Isle Abbotts TA3 6RH. The council had no comments on the application.
- c) Planning Updates and Enforcement: None.

#### 25/45 FINANCIAL MATTERS

- a) FINANCIAL STATEMENT: RESOLVED to approve the financial statement to 30/6/25.
- b) PAYMENTS: RESOLVED to approve the list of payments annexed at the end of the minutes.
- c) BANKING: The Clerk updated the council on the ease of the transferring accounts to Unity Trust Bank, noting that Lloyds are charging a transaction fee per item on the existing account in addition to a monthly fee. Councillors were comfortable that the previously discussed transfer to Unity could now be progressed.
- 25/46 VJ DAY COMMEMORATION: The council RESOLVED to re-imburse costs of providing refreshments for VJ day, noting that a budget of £500 was allocated for such events.
- 25/47 CPRE MEMBERSHIP: Details of benefits of membership was circulated to councillors in advance of the meeting, which highlighted their work to protect the countryside from inappropriate development.

  Noting that they could provide support with planning concerns, the council RESOLVED to trial an initial years membership at a cost of £60.
- 25/48 SRA GRANT: Details for the grant application are being prepared by a resident. The council will support with information as needed.
- 25/49 TRAINING: No requests for training were made, but the Clerk commented that volunteer training (as an alternative to Chapter 8) is now available through Somerset Council.
